The Organization transferred the construction costs for the second floor of the Medical Office Building to Casa Colina Hospital and Centers for Healthcare, a related organization, during the fiscal year ended March 31, 2017. The Organization previously transferred \$6,872,324 of construction costs for the building and improvements during the fiscal year ended March 31, 2014. The Medical Office Building is adjacent to Casa Colina Hospital and Centers for Healthcare's existing inpatient and outpatient operations on its main campus and offers an opportunity to expand the scope of services available to patients.

Exploration, analysis and research of hospital-based outpatient physical (including specialty clinics: pain management, multiple sclerosis and vestibular), occupational and speech therapy programs served within the community.
