Request for Reasonable Cause for not applying a penalty for late filing this 2016 Form 990

We have tried multiple times to file the 2016 return of the Grand Royal Arch Chapter and have resulted in rejections. We have filed over the period from July 27, 2017 to December 9, 2017. Each rejection has been followed up with a call to IRS. Their response was "we have reset things and to wait six to eight weeks then resubmit". Each call has included an apology from IRS, and a comment that a glitch in their system exists or the predecessor employee of IRS has made a mistake.

Grand Royal Arch Chapter lost its exempt status for not filing returns in 2010 thru 2012. Exempt Status was again reinstated on June 11, 2015. Interestingly, the return was filed and accepted for the 2015 year.

We extended the filing date to March 15, 2018 on 7/27/2017 from the original due date of September 15, 2017 as shown on the included "Status History" The call I made on December 9, 2017 the IRS representative said that she could see where the 8868 was filed, however the extension request had fallen off the IRS list of extensions.

As our extension appears to be no longer applicable. I am submitting this "Reasonable Cause Letter" in hopes that IRS will not assess a late filing penalty. We now await a call promised within the next 30 days by IRS to look into this matter. However, in case we meet with the same results as before we are paper filing this return.
