 In FY 2016 PCs for People collected over 13,500 computers and laptops. Nearly 10,000 of these computers were refurbished and distributed to low-income families and individuals. PCs for People also supported the computers distributed with a 90-day warranty and offered discounted repairs after the warranty period. Repairs were \$25 and any parts needed were free. In FY 2016 almost 2,300 repairs were completed at an average cost of \$36 per repair.

This is generally a benefits statement from the county or a tax return proving income is below the 150% poverty level. Proof of eligibility is scanned and filed and the client then chooses a computer. Many recipients give a voluntary donation at this

time. Last year 3,667 personal computers were distributed with no donation from recipients.
