1 Briefly describe the organization's mission:

Advancing AK by uniting practitioners around the world through country or regional chapters with bylaws in agreement with those set by the International Council (IC). The IC is composed of an executive, representatives of 14 international chapters and a rep from each board: the IBE, which holds exams to certify teachers; the IEC, which oversees and updates the universal teaching syllabus used; the IBORS, which standardizes techniques and protocols and overseas research. An IC meeting with congress is held annually.

In 2016, our annual IC meeting and congress was held in Riga, Latvia and hosted by the Baltics chapter. The IC meeting was held on the first day along with meetings of various boards listed above and the AK proficiency and teacher certification exams, overseen by the IBE. A congress was held on days 2, 3 & 4 with speakers from around the world presenting papers on AK related topics. The costs incurred by the Baltics chapter to host members of the IC were covered by funds sent via PayPal (\$6,665) and in Riga, \$400 cash. Other IC expenses include honorariums of (12x\$150=1,800) to those IC members attending (see part IX, line 19c) and \$8,007 for IC executives attending and for their work on behalf of the ICAK throughout the year (see part VIIa). The IC receives no income from the meeting as the host chapter is responsible for organising and running the congress. The IBE incurred expenses (room booking, examiner honorariums etc.) to the amount of \$7,709 of \$9,205 (see part IX, line 19) and received income from fees paid to sit for exams of \$20,537 (see part VIII, line 2a). Income was significantly higher this year over last due to more candidates sitting for exams. The IBE has a treasurer on their executive and maintains separate bank and PayPal accounts, submitting to the IC treasurer an annual financial report, which is included in parts VIII and IX. Other IBE expenses include: \$780, administration and \$706, banking fees. IBE stands for International Board of Examiners. The IBE also held exams at the ICAK-USA annual meeting in Las Vegas.

For 3 years now a fund maintained by the IEC, International Education Council, has been included in the ICAK filing to the IRS. New members who are certified to teach the art and science of AK are charged \$150 every 3 years to maintain their teaching status. The Purpose of this fund is to provide revenue for future IEC initiatives. A recent accomplishment being the design of an online education series to augment in class workshops. The IEC has functioned, like the IC, other ICAK boards and chapters executives, strictly by volunteers over the years. This has affected the ability of the IEC executive to sufficiently meet the needs of its expanding mandate. This fund is meant to cover administration costs and honorariums for work done on behalf of the IEC and the ICAK at large.

4c (Code:) (Expenses \$ 5,899 including grants of \$ 5,899) (Revenue \$ 0)

Like the Baltics chapter did, who hosted the 2016 annual meeting of the ICAK and discussed in 4a above, all chapters hosting the annual meeting can budget for approximately a \$6,000 grant from the IC. Knowing this, a request was made by the United Kingdom (UK) chapter for an advance of this amount as they required funds to secure the reservation of the hotel and facilities to host the 2017 meeting in Edinburgh, Scotland. An amount of \$5,899 (after currency conversion costs and PayPal fees) was sent to the UK secretary-treasurer organizing the meeting. The \$6,000 estimate is based on an average attendance of 15 IC members to the annual meeting at an estimated hard cost to the host chapter of \$400 per attendee. The Baltics chapter above had 17 IC attendees. Part IX, line 3 will reflect the total of the 2016 annual meeting grant (\$7,065) and this grant for the 2017 meeting (5,899) for a total of \$12,964.

Another \$400 was paid in cash at the meeting and after the meeting an amount of \$665 was paid via PayPal to a new IC member who registered for the meeting as a non-IC member, paying the conference fees (\$665) and requiring reimbursement. This brought the total amount paid to ICAK-Baltics to \$7,065 as stated in Part I line (1). Also, in part one, on line(2) is an amount of \$5,899 paid to the ICAK-UK to cover the service costs of hosting the 2018 annual meeting in Edinburgh, Scotland in June, 2018. This was to assist the UK chapter with the downpayment needed to secure the meeting venue. All annual meetings locations are set at least 2 years in advance. Chapters requesting to host the annual meeting must submit a proposal with location and its merits along with a budget. Monitoring the funds is straight forward. Bylaws require all chapter reps to attend the annual meeting. An annual chapter report is submitted as well. This brings a great familiarity between chapter reps and the IC exec and the report keeps the IC abreast of chapter activities. The IC would not agree to a chapter hosting an annual meeting if the chapter was not in good standing and the representative not have sufficient tenure. Also, this is the first time, grants have been paid ahead of the meeting so previously funds were for services already rendered and monitoring not required. For Riga, the Baltics representatives organizing the meeting were medical doctor, with long tenure with the IC. The ICAK-UK rep is the long standing IC secretary so it was with great confidence these funds were released to her in advance. All hosts of the annual meeting are to budget for an IC contribution of approximately \$6,000, as the average attendance is 15 IC members at predicted \$400 net costs per member. There were 17 IC members present at the 2016 meeting in Riga. The odd number (\$5,899) paid in advance to the UK chapter reflects, PayPal fees and conversions costs from 6,000 USD to Pounds Sterling.

In order to add clarity to the narrative in Part III, lines 4a,b&c and bring a better understanding of the services offered by the ICAK to its members I will expand. One could argue that the number one service the ICAK provides is the DIBAK examination process. DIBAK stands for Diplomate in Applied Kinnesiology. Initially, to determine proficiency in AK by all its members and later for those members so inclined and who meet the requirements, to become certified teachers. The importance of this examination process is at first, to promote a high level of skill and understanding of AK, designated by the post-nominal letters, DIBAK. Only DIBAK's can become certified teachers. At an arm's length from the IC is the IBE, a board within the ICAK, which designs exam questions, organizes exams at annual IC and chapter meetings, proctor and grade these exams. The IEC, another board within the ICAK, oversees the recertification of teachers and the standardization of the ICAK teaching syllabus. The IEC has recently designed an online learning program. Both the IBE and the IEC maintain their own treasury and submit reports included in this filing. IBORS, a third board within the ICAK, oversees research and standardization of AK technique.

Form 990, Part VI, line 11b: The ICAK treasurer, who completes this filing, distributes a PDF copy to the IC exec and if timely brings to a hard copy to the annual meeting for review and comment prior to mailing to the IRS. This was done in Riga and again this year in Washington.

Form 990, Part VI, line 12c: If, on the occasion of selecting or engaging a vendor or service provider, anyone in attendance where there could be a perceived conflict of interest, would be asked to recuse themselves from the discussion. If on the occasion of any board member acknowledging a possible conflict or another member being aware of such, the conflict of interest policy is reviewed as it pertains to the immediate circumstances. There is a Judicial/Conflict Resolution Committee (JRC) in place, should such a need arise.

Form 990, Part VI, line 15a,b: The IC reviews compensation of all officers, ensuring they are compatible to like positions in comparable orgs. The IC then approves the compensations, with any changes deemed appropriate, reasonable and fiscally responsible.

Form 990, Part VI, line 19: The ICAK will provide in a timely manner upon request, copies of all governing documents, including conflict of interest and financial statements, whether in writing or person when contacted at the addresses in Form 990, top of Page 1 or Part VI, line 20.

Form 990, Part VI, line 21: The ICAK is an international organization of health professionals and receives dues from its members within and without the US. The ICAK holds an annual meeting with scientific congress for its members. It is hosted by different chapters each year who have submitted a proposal with budget for IC review and vote, at least 2 years prior to the proposed date. In this current year a very success annual meeting was held in Riga, Latvia with funds to support this event reported in Schedule F. Also, in Schedule F are funds provided the UK chapter to assist in organizing and hosting the 2018 meeting in Edinburgh, Scotland. In 2017, the meeting will be in Washington DC and the Australian chapter has already submitted a proposal for review, which has been accepted, to hold the 2019 meeting.
