The organization has done business with keen battle mead relative to most of its insurance requirements for many years, including prior to when timothy battle, a principal from keen battle mead, was elected as a member of the orange bowl committee. Mr. Battle was there after elected to the board of directors for 2010-13 and re-elected in 2016. The board of directors voted to approve a renewal contract with keen battle mead for 2016-17 subject to obc staff ensuring that the terms were fair market value or more favorable to the OBC than market rates, which it did through a review by the risk management committee. Mr. Battle was not involved in the risk management committee's review and did not participate in the vote to approve the contract. It should be noted that while the annual premiums, inclusive of the commissions, paid to keen battle mead are \$353,570 the commissions retained by keen battle mead are approximately only \$38,865. The retained commission of 11% is well within industry norms.
