The St John Auxiliary, Inc is proud to support the patients, families, physicians, and staff of St John Health System 650 volunteers gave 70,847 hours of services throughout 4 of the St John Health System facilities St John Medical Center, St John Broken Arrow, St John Owasso, and St John Sapulpa Volunteers serve in areas such as guest services, information desks, surgery waiting, emergency rooms, patient dismissals, flower delivery, gift shops, pediatrics, pastoral care visitors, and many more We began our \$2 million pledge for telemedicine last fiscal year and we continue to pay off the pledge Nearly all the money is raised from the day to day operations of the St John Auxiliary Gift Shops The St John Auxiliary, Inc firmly believes in inspiring our youth through our junior volunteer program and through high school internships High School students have the opportunity to shadow doctors and nurses and learn about career opportunities in medicine and nursing, and volunteer service to areas of the hospitals This past year we had 221 high school students from 31 area high schools and some of the students were home schooled The students served 17,039 hours of service In addition, we partnered with OU Medical School and hosted "Club Scrubs" This is a program that teaches high school students how to apply for colleges and universities, the curriculum they will face, and guest speakers and presenters teach a variety of topics During the school year, there were between 45-75 students that attended sessions 3 hours each week
