WITH A STUDENT BODY OF APPROXIMATELY 2,700, IT IS LOCATED ON A 200-ACRE CAMPUS ADJACENT TO THE GETTYSBURG NATIONAL MILITARY PARK IN PENNSYLVANIA. THE COLLEGE WAS FOUNDED IN 1832.
