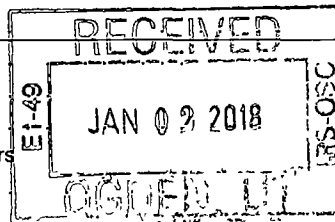

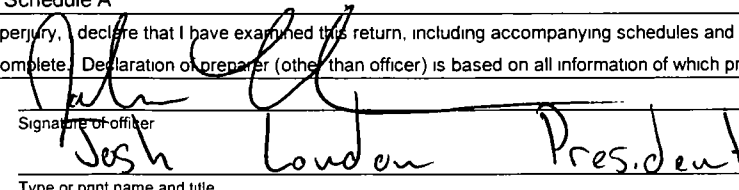

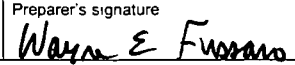

CCHA's program centers around the hockey season which runs from August to April of each year. Summer activities are also organized for the youth. Activities take place at the Wilmington Ice House in Wilmington, North Carolina. Teams in the organization also play at other hockey rinks within the region. Participants receive instruction in the sport of ice hockey; travel on teams to various locations in NC and other states to compete against other teams; participate in hockey camps and leagues sponsored by USA Hockey.

Player Assistance

A number of youth players were given a total of \$9,212 during the fiscal year ended 5/31/17 as a fee waiver to offset a portion of their player fees for the hockey season. The Organization's Board of Directors' assesses each player's parents' financial situation separately and awards scholarships to the extent that funding is available. Any board member with a personal relationship to the player is excused from any discussion involving that player. In addition, the Association promoted youth hockey by contributing \$1,770 to "Beginner's Hockey" during the fiscal year ended 5/31/17.
