The Audit Committee shall meet semi-annually unless a need arises to meet more frequently to review the annual audit and to implement recommendations of the outside auditor to the League. The Audit Committee shall provide the Board of Directors of the League and the Board of Directors of the Keystone Fund with a semi-annual report, and shall also perform those functions set out Article II, Section 1 and delegated to the audit Committee. The Board of Directors may advise or direct the Audit Committee as needed.
