ADDITIONAL NOMINATIONS FOR ANY SLATED POSITION MAY BE MADE IN WRITING BY 10% OF THE ACTIVE MEMBERS WITH THE WRITTEN CONSENT OF THE NOMINEE. THEY SHALL BE RECEIVED BY THE NOMINATING CHAIR AT LEAST TWO WEEKS PRIOR TO THE ELECTION MEETING AND SHALL BE MAILED BY HER TO EACH ACTIVE MEMBER AT LEAST ONE WEEK PRIOR TO THAT MEETING. THEY SHALL BE PRESENTED WITH THE SLATE AT THAT MEETING.

THE SLATE PRESENTED BY THE NOMINATING COMMITTEE SHALL BE VOTED UPON BY THE ACTIVE MEMBERS AT THE ELECTION MEETING HELD IN APRIL.
