Counseling Services has had a 45% increase in students over the past 5 years. 95% of student counseled strongly agree that their participation helped them remain enrolled. This year Veterans Affairs (VA) partnered with CSU and brought VITAL services to campus to help Veteran students. CSU Athletics also partnered with Counseling Services and brought athletic mental health and Title IX awareness. Body Image Week also brought various outside organizations to host a continuing education workshop for community mental health professionals. Counseling Services created additional programming and events to promote mental health and well-being which included therapy dogs and aqua-massage this past year. The Counseling Services team is dedicated to responding to student mental health crisis situations across campus, and continuing to participate in college counseling center national data collection for research purposes. Campus Recreation is in process of implementing new software to track usage. We offer exercise classes, intramural sports, and other opportunities to encourage students to stay active and healthy. Campus Recreation saw over 4,000 participants this academic year, and 998 participants in group fitness for the Fall 2016 semester. Residence Life's departmental mission is to create a community that honors God, and enables students to thrive. The focus is on four key areas: Jesus, Neighbor, Community, and Disciples. Residence Life had over 1,300 resident students in the Fall, and 1,191 in the Spring. 75 new furniture units were purchased for Russell East. Monthly Resident Assistant Dinners and Resident Assistant Hall events, including bible studies, build community involvement. All Resident Life employees participated in refresher training in Title IX, and counseling training with CSU's Counseling Services. CSU's Residence Life Department hosted the South Carolina Housing Officers Association Conference in the Fall of 2016. This conference brought Residence Life staff from the entire state together. Student Activities had 34 student organizations this academic year. This is 5 more than last year. Student organizations and the American Red Cross had 8 blood drives with 400+ donations this academic year. CSU Alumni and News Anchor, Tessa Spencer, was master of
