Effective March 1, 2017, BJUI conveyed a portion of its assets, including the operation of the higher education programs, the elementary school programs, and certain related assets (together "Gifted Assets") to BJU, Inc. ("BJU" or "the University"), a South Carolina not-for-profit corporation. The assets transferred included cash, investments, property and equipment, intellectual property, student accounts receivable, student and faculty notes receivable, inventory, and prepaid expenses. Certain cash and investment balances had been maintained by BJUI as temporarily restricted and permanently restricted in accordance with donor-imposed stipulations and those cash and investment balances were conveyed to BJU, subject to the same restrictions. BJUI also transferred certain liabilities, principally obligations with respect to the terms of employment of program-related employees, and deferred revenues of its higher education programs. BJU recorded the Gifted Assets at fair market value. The fair market value of property, equipment, and intellectual property was established based upon an appraisal performed by a qualified professional services firm. The fair market value of investments was established based upon quotations obtained from national securities exchanges. The fair market value of the remaining assets received was established at the carrying values in the records of BJUI at the date of the gift because such carrying values approximated fair value due to their short maturities.
