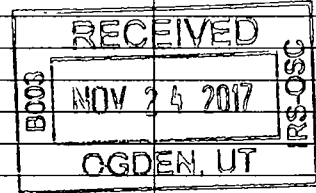

IN MANY COMMUNITIES ACROSS THE COUNTRY, THESE UNIVERSITY CLINICS PROVIDE A UNIQUE SERVICE. THEY ALSO SERVE TO PROVIDE A TEACHING BASE FOR THE STUDENTS. SOME OF THE FUNDS WERE USED FOR BASIC RESEARCH REGARDING STUTTERING.
