GOVERNANCE COMMITTEE WHICH IN TURN SHALL PRESENT THE NOMINATION TO THE

BOARD OF TRUSTEES FOR ITS ACTION. QUORUM IS ESTABLISHED WITH FIVE OF THE

COMMITTEE IN ATTENDANCE OF WHICH AT LEAST THREE (3) ARE ELECTED OFFICERS.

THE PRESIDENT OF THE BOARD OF TRUSTEES MAY, FROM TIME-TO-TIME, APPOINT

SPECIAL NON-VOTING MEMBERS TO THE EXECUTIVE COMMITTEE. THE EXECUTIVE

COMMITTEE SHALL EVALUATE THE EXECUTIVE DIRECTOR ANNUALLY, OVERSEEN BY THE

PRESIDENT AND 1ST VICE PRESIDENT.
