



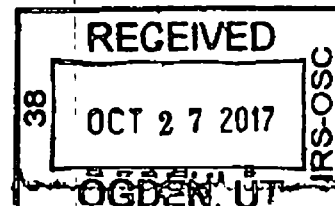

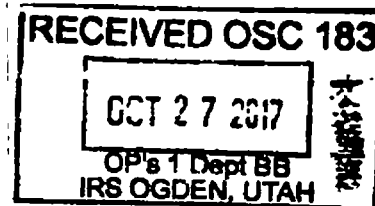

Dear Taxpayer:

We received your Form 990-EZ, Short Form Return of Organization Exempt from Income Tax, for the tax period above and need additional information. Send only the information we're requesting. Don't send a copy of your return unless the information we've requested changes your original return.

In addition to providing the missing or incomplete information, include a reasonable cause explanation of why you didn't submit the required information with your return, if applicable. We may charge you a penalty if you fail to provide both the missing or incomplete information, and a reasonable cause explanation.

We don't consider your return filed or complete until we have all the information we need to process it. The date we receive the information we've requested, is the date we consider your return filed.

The law provides a penalty of \$20 a day for filing an incomplete return. The maximum penalty may be as much as \$10,000 or five percent of the gross receipts for the year, whichever is less. If your organization has gross receipts exceeding \$1,020,000, the law provides a penalty of \$100 a day for filing an incomplete return. The maximum penalty may be as much as \$51,000. The amounts in this paragraph may be increased by inflation adjustments as required by law.

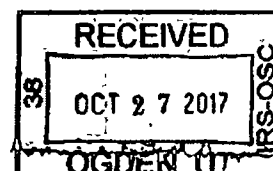
