Protect and preserve African wildlife in its native habitat. The most important work we do is anti-poaching and conservation in Mana Pools National Park, which is a UNESCO Natural World Heritage Site, and in the Zambezi River Valley of Zimbabwe and Zambia. We also monitor and track iconic bull elephants, develop infrastructure to establish ongoing ranger presence in vulnerable areas, and provide funding to support local community health and welfare needs.

Anti-poaching work during the rainy season was extremely successful. Not a single elephant in the Mana Pools National Park was reported shot. This compares to the same period the prior year, when numerous elephant carcasses were found. Remote tented base camps were established in four strategic areas. Vehicle fuel and maintenance and a driver were provided at each camp. Wildlife rangers were provided food and water rations. Boat fuel and maintenance was provided along with a driver on the Zambezi River to deploy rangers reacting to any shots fired and for routine patrols. Ground coverage was extensive, with 1600 ranger patrols covering the majority of Mana Pools as well as adjacent wildlife habitat. Boat patrols also extended throughout and beyond the National Park. Through collaborative work with other nonprofits, NGO's and National Parks, 7 elephant poachers were arrested, 11 arrests involving pangolin and 9 arrests involving other wildlife were made. A collaring program was initiated, with four collars purchased and one bull elephant successfully collared. A medical clinic was established for members of the local community and funding was provided for equipment and supplies.
