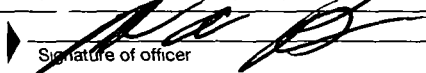

Form 990 EZ - Part III - Primary Exempt Purpose - The primary purpose of Arizona Aloha Festivals, Inc. is to plan and produce a cultural festival providing an opportunity to educate the general public about the cultures and lifestyles of Hawaii and other Polynesian islands.

Form 990 EZ - Part III - Line 28 - Arizona Aloha Festivals, Inc has successfully produced the Arizona Aloha Festival for the past 23 years.

Over the years, the Festival has received funding from both state and local arts commissions, local governments, corporations, and the public at large. The Board of Directors provides strong financial oversight and its members come from diverse fields. The chairperson is appointed by the Board and reports directly to them. The Planning Committee is composed of chairs of the committees responsible for operations and programming. All Board of Directors and Planning Committee members are volunteers. The Festival's programming is known throughout the community, state, and region and regularly lands on lists of top events in the Phoenix metro area and Arizona. The strength of the organization lies in its diversity. The Festival enjoys strong support from local South Pacific Islander organizations such as the local Hawaiian Civic Club (30 + years in the Valley), dance schools, performing groups, Hawaiian outrigger canoe clubs and other sports organizations, corporate supporters, and more.

The 2017 Arizona Aloha Festival showcased arts from the cultures of Hawaii and other South Pacific Islanders, thereby increasing cultural awareness and opening the door for educational opportunities. Performing artists were selected based upon their reputation in the South Pacific Islander arts and chosen both based on their ability to provide a meaningful experience to the viewing public and to enrich the skills of the local artist community. Performing groups from neighboring states were also included to broaden the Festival's offerings. Guest artist programming serves to link the source island culture to the Arizona island cultural artists. As the two are isolated from one another, the danger is that the source island culture is romanticized and trapped in time by the Arizona artists...never to evolve as art forms. This can also happen in reverse: The Arizona artists grow and develop the traditional arts while the source cultural art stays stagnant. It is the interaction between the two that spurs the creativity of both.

The Festival provided a range of activities to the public and to the collaborating partners, promoting both cultural diversity and diversity through the art forms presented. The Festival utilized local experts and artisans from our vendor marketplace as well as having guest artists from Hawaii to expand our performance and educational offerings.

The 2017 Festival was very successful, drawing in excess of 150,000 attendees and provided free cultural activities and performances for both adults and children over the two day event. The Festival also conducted two lei making workshops in locations outside of the Phoenix metro area to increase the exposure to the Polynesian cultures in other parts of the state. Approximately 75 people attended these free workshops.
