Part IV. 1a - The Executive Committee consists of the co-presidents, vice-presidents, secretary, and co-treasurers who make some executive decisions; however, all monthly meetings are open to the public. Decisions regarding membership approval are made at meetings held three to four times a year.

Part IV. 19 - The PTSA holds a once a year fundraising event to fund its mission. An auction committee is formed under the supervision of the executive committee, and all income and expenses are reviewed by the executive committee. All receipts for expenses are maintained and reviewed before paid. All records are open to the public.

Part VI. 8a - At every Executive Committee meeting we have a member record and keep minutes that are available to the public.

Part VI. 8b - Each sub-committee has documentation for their actions taken on behalf of the governing committee.

Part VI. 19 All PTSA documents are available upon request. The co-treasurers and secretary have records available at monthly meetings.
