THE WHITE MOUNTAIN SCHOOL PARTICIPATES IN A NUMBER OF NATIONAL AND REGIONAL PROFESSIONAL ASSOCIATIONS FOR INDEPENDENT BOARDING SCHOOLS, INCLUDING THE INDEPENDENT SCHOOLS ASSOCIATION OF NEW ENGLAND. SALARY COMPARABILITY DATA IS READILY AVAILABLE THROUGH THIS SOURCE TO BOTH THE BOARD OF TRUSTEES AND THE HEAD OF SCHOOL. COMPARABILITY DATA IS USED BY THE HEAD OF SCHOOL FOR DETERMINING COMPENSATION OF OTHER MANAGEMENT EMPLOYEES, AS WELL.
