EJPs mission is to work with individuals and systems to break down the barriers that prevent access to crucial economic resources. EJP staff help service users regain confidence in personal finance, build employment readiness, and secure transitional and permanent housing. Within the EJP is the Transitional Housing Program. Steps to End Domestic Violence and Burlington Housing Authority BHA collaborate on an 11-unit apartment complex, Sophies Place, to which those who have experienced domestic violence have priority for available units. Steps to End Domestic Violence also provides transitional housing in a scattered site model in which rental assistance may be provided for those living in housing units throughout the community. Advocates work with participants as they stabilize housing.
