

Part I, Line 1a	When the president's spouse travels and it is paid for by the university, she is performing duties on behalf of the university. The President resides in a university-owned housing, which is less than 1/2 mile from main campus. By locating him in close proximity to the University, it helps to make the President available for the daily interaction between the community and the University staff/students/alumni/donors and physical plants. The University-provided housing is geographically integrated with the University's educational property. The President's residence has been owned by the University for a substantial number of years. Prior Presidents have been required to reside there. The President performs many University tasks and functions at the residence. The residence is furnished for the convenience of the University and is required to be occupied by the President as a condition of his employment. As the University's principal fund-raiser, the President entertains actual or potential benefactors, visiting dignitaries and community leaders in the residence. The heaviness of the President's administrative workload, the presence of University-related social functions and the number of conferences scheduled with students or faculty members require access to the majority of the residence. In addition, the University conducts other events that are essential to its educational exemption. In lieu of the aforementioned intricacies of multiple uses by many multiple parties involved, it is impractical and would not be considered an accurate calculation of the fair market value of qualified campus lodging furnished to the President. Due to these factors, the University has decided to omit entering the estimated amount of tax free housing allowance provided in column F of Form 990, Part VII, Section A and Schedule J, Part II, Column D - "Nontaxable Benefits." The university provides a house cleaner for the president and also performs all necessary maintenance on the home. The president is also reimbursed for expenses relating to financial services advice.
