Academic Support and Student Services - Includes expenditures for activities that support and enhance the student's education, as well as contribute to their emotional and physical well-being. Included in this category is the University library which houses over 155,000 print volumes, subscribes to 13 print journals, and provides access to 278,000 e-journals, 37,000 e-books, and 100 electronic databases for articles, reference content, statistics and beyond. During fiscal year 2017, students checked out 17,000 books and Course Reserve items. Also included in this category is the University's Health Center whose staff handled 3,900 student/patient visits during fiscal year 2017. Another component of this category is the Career Education Center which had 2,000 student contacts during fiscal year 2017 through multiple channels.
