United Way of North Central Massachusetts made \$2.1 million in grants and distributions during the year. In addition to its grantmaking, United Way is focused on mobilizing the caring spirit of the community through its volunteer center. The goal of these grants and distributions, and the work of our volunteers, is to provide immediate assistance to those in need, while creating a community where everyone has the opportunity for a better life. United Way creates these opportunities through its work in the areas of education, income and health—the building blocks for a better life. United Way's priorities include youth development and education, substance abuse and domestic violence, and emergency food and shelter. In addition to funding 37 programs, which delivered over 89,560 health and human services, through local nonprofits, United Way also has community initiatives that include United Way Youth Venture, which inspires and invests in teams of young people, to design and launch their own lasting social ventures. Dolly Parton Imagination Library was implemented in November 2012. It is a preschool literacy program that provides children with a new, FREE, age-appropriate book each month from birth until their 5th birthday, regardless of socioeconomic status. This program ensures that children have quality books in the home in their most developmental years. Any child living in Ayer, Shirley, Fitchburg, Leominster, Gardner, Winchendon or Templeton may sign up for the program. The program delivers 2,567 books a month. 698,734 books have been delivered since the start of the program. The Volunteer Center role in the community is to inspire, motivate and mobilize North Central Mass. businesses, residents to engage in collaboration and volunteerism within the community to positively impact the local communities. The Volunteer Center partners with the N. Central Mass. non-profit agencies to increase their capacity to assist the residents in need of services by utilizing the power of volunteers as a resource. The Volunteer Center website <http://volunteer.uwncm.org> is an online resource that provides a platform for agencies to inform the community about their mission, community work, volunteer needs and agency events. Local residents, companies and schools utilize the Volunteer Center to discover ways to assist the community by volunteering for the agencies. The Day of Caring continues to be the largest community volunteer event of the Volunteer Center. The September 16, 2016 results: 40 agencies, 54 projects, 746 total volunteers including 146 at the Combat Hunger events sponsored by Mount Wachusett Community College. Additionally, 2,000 Leominster Public Schools students Combat Hunger is a United Way initiative that focuses on eliminating hunger in N. Central Mass. by planning and conducting large meal packaging events sponsored by local corporations. July 1, 2016–June 30, 2017: 20 NCM food pantries received the nutritionally fortified packaged meals. Volunteer Center managed the food pantry meal needs for each event. Distribution has expanded to include community meals, summer programs, and schools. 6 Events, 1,326 volunteers, 2,705 volunteer hours, 247,700 meals packaged. Mass 2-1-1, which is sponsored by United Way, is a free information and referral service that connects residents to health and human services in the community. Hundreds of local residents have used the service. 53,398 calls from our area with 90,231 requests. FamilyWise affords prescription discounts and savings to local residents that are uninsured or underinsured, saving area residents over \$1.3M since the program was launched locally. \$86,830 was saved this year from the program. United Way's Emergency Shelter Fund provides shelter to homeless individuals during extreme winter events and situations. Over 89 individuals were helped with 34 nights of lodging. United Way once again hosted its annual heating forum, which provides critical information to nonprofit agencies on the various heating assistance programs.

Form 990, Part III, Line 4b:

A special fund raising campaign was initiated a couple of years ago in response to the increased need for Safety Net Services. This campaign proved critical to our being able to respond to a stubbornly high unemployment rate. One hundred percent of all funds raised were granted to agencies that had the network capabilities to get food and energy assistance to those most in need. Over 20,000 individuals and families (combined) received some form of food assistance including meals packaged by Combat Hunger Initiative. Over 145 people received fuel or utility assistance. A total of \$73,000 dollars was granted to provide emergency capacity building help to prevent 1 agency from having to close its doors due to extraordinary - temporary, financial crisis, and prevent 2 agencies from a disruption of service provision or to increase the # of people they were able to serve.

United Way Youth Venture (UWYV) reaches out to young people and inspires them to take initiative and make a positive, lasting change in their communities. When young people learn early in life that they are powerful and capable of leading social change, they are more likely to continue to lead throughout their lives. UWYV is a three way partnership between Ashoka's Youth Venture, Mount Wachusett Community College and United Way of North Central Massachusetts. This program is in 14 school systems and has reached over 10,408 students in the past year, actively engaging 6,469 students.
