AS THE AAA, SPRINGWELL IS THE REGIONAL HUB OF SERVICES FOR SENIORS AND IS RESPONSIBLE FOR DEVELOPING COMPREHENSIVE, COMMUNITY-BASED SERVICES THAT MEET THE NEEDS OF ALL OLDER ADULTS. SPRINGWELL IS ALSO THE DESIGNATED PROTECTIVE SERVICES AGENCY FOR A 17 TOWN AREA. IN THIS CAPACITY SPRINGWELL RECEIVES REPORTS OF ELDER ABUSE, ELDER SELF-NEGLECT, AND FINANCIAL EXPLOITATION. STAFF INVESTIGATE SUCH REPORTS AND ENDEAVOR TO PROVIDE SUPPORT THAT HELPS REDUCE ABUSE, NEGLECT AND EXPLOITATION. FINALLY, SPRINGWELL OFFERS NUTRITION SERVICES INCLUDING HOME DELIVERED MEALS, COMMUNITY DINING SITES, RIDES TO MEDICAL APPOINTMENTS, ASSISTANCE WITH GROCERY SHOPPING, FRIENDLY VISITORS AND EVIDENCE BASED EDUCATIONAL WORKSHOPS.
