The Board reviews the Form and makes comments and suggestions for revisions at their regularly scheduled April meeting. The final Form 990 is then produced and reviewed by the Director of F&A for accuracy. The final Form 990 is sent to the Chairman of Audit and Finance committee for his review. Once the form has been reviewed, it is signed by the President/ceo and sent to the IRS.

Form 990, Part VI, Section B, line 12c	The organization has a conflict of interest policy that was approved by the Board of Directors in 2003. The Board reviewed the policy in conjunction with the requirements of the new Form 990 and the policy was expanded in scope to include more emphasis on financial conflicts as well as conflicts in the award of scientific grants and contracts which was the emphasis of the original policy. The updated policy was approved by the HEI Board of Directors in April, 2010. It requires all officers, directors, and key employees to file an annual disclosure of any interests, financial or scientific, that could potentially be the source of conflicts. Under the current policy, the members of HEI's Health Research Committee and Health Review Committee are required to submit annual Conflict of Interest disclosures to the Director of Science who reviews them and raises any potential concerns with the HEI President. The new policy expands the annual disclosure to all Directors and key employees. The Director of Science will continue to review the statements for scientific conflicts and the Director of F&A will review them for financial conflicts, with each referring any concerns to the HEI President to determine if any action is required.

Form 990, Part VI, Section B, line 15	The salary of HEI's CEO/Executive Director is set according to a process that was established by the independent Board of Directors and led by the Chair of the Board Committee for Governance and Compensation. The Chair of the committee conducts a performance review that includes input from a self-evaluation and input from other HEI staff. A salary survey was conducted by Quatt Associates using not for profit organizations similar to HEI to arrive at salary levels for the HEI CEO and all other staff. The performance evaluation and the salary data from the survey are the criteria used to determine the salary. The deliberations of the Committee are recorded contemporaneously and documentation is provided by the Chairman of the Board of Directors to the HEI Director of Finance and Administration. The process to determine salaries for other officers and key employees is based on the same comparability data that the Board of Directors uses to determine the salary of the CEO. The CEO/Executive Director conducts performance evaluations for the other officers who report to him and sets their salaries based on the performance evaluations and the comparability data for their positions. The salaries for other key employees are set using the same comparability data after a performance review conducted by the officer in charge of their department, with input from their immediate supervisor if appropriate. The salary comparability data is updated periodically, and adjustments made to all salary scales as appropriate and based on market conditions for comparable positions and organizations.
