During 2015, the Foundation became a partner with the Association in a grant agreement funded by the Health Care Workforce Transformation Fund, and administered by Commonwealth Corporation. The grant is on a cost reimbursement basis for allowed program expenditures. The period of the grant will be from February 1, 2015 through January 31, 2017 with the maximum amount of the grant to be approximately \$164,800. The Association acts as an agent under the grant in which it submits requisitions for reimbursable costs to Commonwealth Corporation. Upon receipt of the grant funds, the Association will transfer these funds to the Foundation to be used for the purpose of the grant. During the years ended June 30, 2017 and 2016, the Foundation collected \$91,588 and \$67,465, respectively, of grant funds from the Association, which is reflected in the statement of revenue, expenses and changes in net assets as temporarily restricted grant income. Grant expenses incurred during 2017 and 2016 were \$3,833 and \$93,326, respectively. Included in grant expenses are reimbursements to the Association for costs incurred under the grant.

The Foundation evaluates tax positions taken, including the position that the Foundation qualifies as a tax-exempt organization, and evaluates whether the tax positions are more likely than not to be sustained upon examination by the Internal Revenue Service. Since the Foundation utilizes the modified cash basis of accounting the resulting impact of these tax positions are recognized in the financial statements when actually paid, based on the result of this evaluation. Management has analyzed the tax positions taken by the Foundation, and has concluded that as of June 30, 2017 and 2016 there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Foundation believes it is no longer subject to examinations for years prior to June 30, 2014. The Foundation's policy is to recognize any interest and penalties related to tax matters as an expense when paid.
