In connection with any actual or possible conflict of interest, an Interested Person must disclose to the Board Chair, the Chair of the Governance Committee or their designee the existence of his or her Financial Interest and must be given the opportunity to disclose all material facts to the School's trustees considering the proposed transaction or arrangement. If an Interested Person believes that he or she has a conflict of interest, such person shall recuse himself or herself from all further discussions with respect to the matter giving rise to the conflict of interest and shall not vote on any matters with respect thereto. If an Interested Person is uncertain as to whether he or she has a conflict of interest, he or she shall seek a determination by the Board as to whether a conflict of interest exists. Such Interested Person shall be bound by a decision of the Board with respect to the existence of a conflict of interest. After disclosure of the Financial Interest and all material facts, and after any discussion with the Interested Person, the Interested Person shall leave the Board meeting while the determination of a conflict of interest is discussed and voted upon. The remaining Board members shall decide if a conflict of interest exists.
