Scholarships and other academic awards are one of the primary objectives of the Foundation. In the 2016/2017 academic year, 454 students were awarded scholarships. The amount reported above is for the six months ending June 30, 2017 and does not reflect a full year of scholarship expense. Scholarships bestow on students a valuable sense of recognition and accomplishment as well as important financial support. Our scholarship donors include private individuals, corporations and foundations, all of whom are committed to making an education affordable for NCC students. The Foundation's scholarship process is competitive and academic achievement is the primary consideration. However financial need, special circumstances and personal qualities are also considered in awarding scholarships.

4b (Code) (Expenses \$ 342,168. including grants of \$ 292,283.) (Revenue \$)

The Foundation supports Norwalk Community College to further the development of the student body by providing funding for a variety of programs. The amount reported above is for the six months ending June 30, 2017 and does not reflect a full year of support to Norwalk Community College. The Foundation continued its support from previous years to fund five faculty positions for the Center for Science Health and Wellness. In 2016, a commitment to fund four of the faculty positions was extended for an additional three years. The fifth faculty position is funded by a three year grant. In accordance with Generally Accepted Accounting Principles, the entire liability for the long term grant funding of the five faculty positions was established and the expense was accrued, but operationally the faculty positions
