Each resident enjoys various recreational and social activities on a regular basis. Each resident is also involved in every facet of the home environment, including cooking their own meals, shopping for food and household supplies, and doing regular household chores. (cont'd on Schedule O) (cont'd from Page 2) The goal of QSAC's residential programs is to create a nurturing environment that promotes personal growth and a sense of dignity in each of our residents.

The QSAC School age program expanded to the Bronx during FY 2017. The site officially opened in January 2017. QSAC's Day School program provides children 5 to 21 years of age with an appropriate education, implemented in the least restrictive environment.
