28	In the previous 12 months, the Peace Appeal Foundation continued its work with local and international partners supporting dialogue and peacebuilding efforts in conflicts in Cyprus, the Middle East, Myanmar/Burma and Nepal. In each of these conflicts our network of advisors accompanies local actors in the development and support of nationally led peace and dialogue processes, providing technical assistance, helping mobilize resources from international donors, assisting knowledge sharing and exchanges among parties, and more. Among the past year's highlights: At the Common Space Initiative in Lebanon, formal and nonformal dialogues made progress on several fronts. The Lebanese Palestinian Dialogue Forum published the findings of a multi-year effort focused on Palestinian Camp Management with significant breakthroughs and recommendations, including upgrading the status of their camp governing committees. Following three years of dialogues, research and consultations by Lebanese political parties in the Common Space, the parties finally tabled a consensual Decentralization Law in Parliament this year. Additionally, progress was made through dialogue and a joint publication of key strategies and principles to re-launch the "Socio-Economic Council (relaunched in October of 2017). The main parties in Lebanon agreed on a Common political, economic and social vision and principles communique on how to address the Syrian Refugee Impact on LEBANON (now almost 1.8 million). The Common Space continues to host the Syria Initiative, aiding local peacemakers throughout the region. At the Cyprus Dialogue Forum, our partners continued to expand the Forum's core group of stakeholders in the year to comprise to include over 100 organizations including Business and Professional Associations, Trade Unions, Political Parties and civil society organizations from multiple fields. Meeting regularly, the Forum's task groups address six thematic areas, building shared understanding of common issues and generating options that feed into both official and nonofficial channels for consideration and implementation. The Peace Appeal's support for partners addressing the ongoing peace process in Myanmar/Burma continued. Continuing their work with local partners on the ground, our partners and associates aided stakeholders in the preparation for the two sessions of the 21st Century Panglong Union Peace Conference. Additionally support was provided in separate reviews related to stakeholders who have not signed the Nationwide Ceasefire Agreement. In parallel efforts focused on supporting state-based processes and regional common spaces in Myanmar, which hosted multiple consultations at the regional level to provide input into the national political dialogue. To improve the practice of peacebuilding our efforts over the course of the year emphasized research, the ongoing development of knowledge sharing platforms, as well as sponsoring and participating in exchanges, conferences and events focused on formal and nonformal dialogues. Our associates and partners were featured at the 3rd International National Dialogues Conference held in Helsinki, Finland, an event which we co-sponsored a delegation from Zimbabwe. Through our membership, support and work with the Charity and Security Network ("CSN"), we continue to work to improve the enabling environment for peacebuilding and humanitarian relief organizations. The CSN released a comprehensive report on "Financial Access for US Nonprofits" was released in March, documenting the much larger scale of challenges nonprofit organizations face with the phenomenon known as "derisking" by commercial banking institutions.
