The School is a non degree granting overseas research institute, with a 9 month program of study for approximately 20 graduate level students, an independent study facility for some 80 plus post graduate scholars and a 6 week summer program for about 40 students and teachers. In addition, there are study trips made available to students and visiting scholars. The School maintains 3-4 full year faculty.

4b (Code: 611710) (Expenses \$ 3,451,896 including grants of \$ 111,380) (Revenue \$ 3,872,719)**Excavations:**

The School maintains two active excavations at the Athenian Agora and the Cornith site which are year round sites. During the summer approximately 40 students take part in a 8 week excavation season at the Agora. Both excavations maintain archaeological collections which are overseen by the Greek Archaeological Service.

4c (Code: 611710) (Expenses \$ 3,361,554 including grants of \$ 3,680) (Revenue \$ 3,066,997)**Publications and Libraries:**

The American School maintains and operates two research libraries holding about 240,000 volumes. The Blegen Library has one of the most complete collections in the world for research in the civilization of ancient Greece. The Gennadius Library houses both volumes and electronic resources which comprise the most significant collection for the study of Hellenic civilization after the end of antiquity.

The School publishes scholarly research in the form of books (3-5 volumes per year) in addition to a quarterly Journal. The current catalogue of available publications is about xxx titles.
