These funds supported the daily education of 350 children in the main school in Kabul as well as literacy training for 300 children in IDP (internally displaced persons) camps around the city. More than 2,000 children throughout the year benefit from outreach programs including vocational training, mobile library and recreational activities. The funds were used for teacher salaries, supplies, and utilities and building maintenance.

These funds supported satellite schools in Mazar-i-Sharif and Gardiz. A total of 250 students are served between these locations. As above, the support includes salaries, supplies, rental space and utilities.
