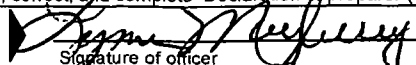

During 2017, Child Protect conducted 259 forensic interviews with suspected child abuse victims. We coordinated & provided 58 forensic medical exams for sexual assault victims. 33 Child Protect cases resulted in criminal charges against suspected child abuse perpetrators with 27 indictments on child abuse charges during the year, 8 cases ended in criminal convictions. CP referred 161 child abuse survivors for therapy services, we provided trauma-based therapy services to 80 trauma survivors in 2017. We provided advocacy & support to 480 children during the year & child abuse prevention programming to 3097 Mercer County Students. We also provided education & awareness training to 208 adults in our community during 2017.
