FIRST Tech Challenge - Over 160 teams participated in Illinois during this past year. The season included leagues, meets and qualifying tournaments and an Illinois state wide championship. Approximately 1500 students were involved in the program.

FIRST Robotics Competition - The FIRST Robotics Competition activity in Illinois is run by FIRST (501 c3 in New Hampshire). Inscite Illinois assists FIRST in this program. The majority of the revenue within Inscite Illinois related to FIRST Robotics Competition was local fund raising and expenses payments to FIRST to cover a portion of running the Midwest and Central Regional FIRST Robotics Competitions in Chicago and Peoria Illinois respectively. Approximately 1500 students were involved in the activity in Illinois.

In the case of FIRST Robotics, FIRST (EIN 22-2990908) is the primary organization operating the FIRST Robotics Competitions in the United States and was the primary organization that ran the Midwest regional championship in Chicago in April 2017 and the Central regional championship in Peoria in March 2017. This grant to FIRST represents donations received by Inscite Illinois (DBA FIRST Illinois Robotics) for the FIRST Robotics competitions in Illinois.

For the individual teams, Inscite Illinois (DBA FIRST Illinois Robotics) receives funding with some temporary restrictions to fund individual teams. Teams are provided grants after providing receipts showing matching expenses for their robotics teams. Inscite Illinois (DBA FIRST Illinois Robotics) separately tracks the restricted donations and provides grants only after receiving evidence of expenses related to robotics education activities. The restrictions are time bound and generally lapse after one year.
