"Native Strong: Native Strong is a national program of grantmaking, technical assistance, research, communications and advocacy. Through the Native Strong program, the Notah Begay III Foundation provides grants to tribes and tribal organizations that support community-based programs that focus on children's nutrition education, access to healthy foods, increased physical activity and culturally-based youth/community leadership development. Native Strong staff provide technical assistance and meet with grantees on a regular basis, and grantees provide quarterly progress reports.

In the last fiscal year, Native Strong awarded 14 grants totaling \$627,636 (Cont'd on Sch. O)

NB3FIT is a direct service youth sports and leadership program currently serving Native American and tribal communities in New Mexico. Through the NB3FIT sports programs, the Notah Begay III Foundation has experienced changes in children's healthy habits, increased awareness of and better nutritional choices made, increased levels of physical activity, and a more positive outlook for the future as obesity and type 2 diabetes are not seen as inevitable developments.

The core values of the NB3FIT program is to get Native youth healthy and active through sports, such as the golf, soccer and cross country programs. NB3FIT coaches teach about food and nutrition so youth can make healthy
