Under the plan, OPAS Foundation endorses the right to designate a beneficiary for the portion of the death benefit in excess of the greater of the cash surrender value or premiums paid. The value of that right, which was included in the Officer's reportable compensation was \$1,443. OPAS Foundation also sponsors an additional 457(f) deferred compensation plan effective January 1, 2014. As of 6/30/2017, the Officer's deferred compensation account was credited with \$100,000.
