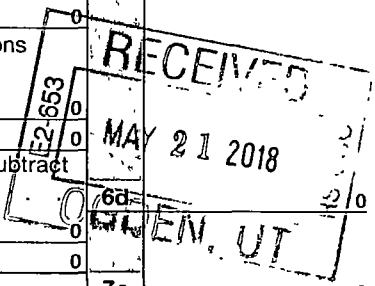

990 - EZ Part 1 #10 - \$31,174 was paid out in grants to Kent Intermediate School District (2930 Knapp NE, Grand Rapids, MI 49525). Of that, \$14,800 was for the Bright Beginnings Program to purchase hours for Parent Educators to serve high-risk families via home visits. Also included was \$7,850 paid towards the Greater Grand Rapids Spelling Bee expenses. The remaining \$8,524 were grant fund expenditures under \$5,000.

Part 1 #16 - Other expenses totaled \$26,707. The majority of these expenses were for meeting, including room rentals, meals, lodging for retreats, entrance fees, parking, and conference expenses. This includes meetings for the Kent Intermediate Superintendents Association, Kent Intermediate Association of School Boards and a couple project-based learning activities and supplies for high school students. There was also a \$20 expense for the Nonprofit Corporation Filing Fee and \$95 annual fee for the Kent Education Foundation Credit Card.

Part 3 #31 - The "other program services" included \$11,794 spent on field trip expenses for high school students to visit USS Silversides and a retirement community(\$549), \$3,125 was used to pay for t-shirts and conference registrations for local district's Gay Straight Alliance programs, \$7,850 helped cover Spelling Bee expenses, and transportation expenses for students attending job shadow opportunities to assist in career exploration amounted to \$270.
