General Programs including NightLight Atlanta - NightLight International's administrative operations support the anti-trafficking programs being carried out at each NightLight location. Wherever possible, NightLight seeks to streamline and coordinate administrative efforts in order to minimize overhead and maximize each location's impact. In addition, NightLight International's administrative operations seek to continually unify and engage all NightLight locations in carrying out NightLight's unique mission and vision. NightLight Atlanta - Ministers weekly on Friday nights and outreaches to people working in the sex industry of Atlanta. Kids' Club is for at-risk kids in the neighborhood on Thursday nights. We partnered with a local church to take the children in the neighborhood to church activities on Sunday mornings. Counseling is offered to individuals in the sex industry out of the outreach center, the staff spoke at numerous events, spearheading official standards of care for survivors among our peer organization.
