CASE MANAGEMENT - JFCS provides resources and information to help individuals and families in need, including information and referral, kosher food pantry, including a nutritionist available during pantry visits, and emergency financial assistance. In FY 2017, we served 325 Kosher food pantry clients, distributed 2,200 bags of groceries. Through the annual backpack drive, JFCS distributed a record 96 backpacks to case management and clinical clients in need to outfit them for back to school.
