IN ADDITION, 78% OF GCU STUDENTS RETURNED AFTER THEIR FIRST YEAR, WHICH IS CONSIDERABLY HIGHER THAN THE NATIONAL AVERAGE (69%). JUST AS THE UNIVERSITY CONTINUES TO GRADUATE HIGH-QUALITY, HIGH-PERFORMING ALUMNI, GCU IS ATTRACTING BETTER PREPARED STUDENTS. FOR EXAMPLE, IN FALL 2016, THE AVERAGE INCOMING FRESHMAN HAD A 3.27 GPA, UP FROM A 3.25 GPA IN 2015. GCUS GROWTH IS NOT LIMITED TO ITS HISTORIC LAKEWOOD CAMPUS. DURING 2016-17, GCU SIGNED NEW PARTNERSHIP AGREEMENTS WITH TEN CATHOLIC HIGH SCHOOLS, GIVING THEIR HIGHEST-PERFORMING STUDENTS THE BENEFIT OF GUARANTEED ADMISSIONS, ONE-ON-ONE COLLEGE ADVISING AND SPECIAL SCHOLARSHIP FUNDING. SIMILARLY, THE UNIVERSITY ENTERED NEW AGREEMENTS WITH AREA COMMUNITY COLLEGES, INCLUDING CUMBERLAND AND COUNTY COLLEGE AND BROOKDALE COMMUNITY COLLEGE. THE UNIVERSITY LAUNCHED ITS NEWEST PROGRAMS TARGETING ADULT LEARNERS THROUGH THE NEW GCU@HAZLET, A PARTNERSHIP WITH BROOKDALE AT ITS NORTHERN MONMOUTH EDUCATIONAL CENTER. AT THE SAME TIME, THE UNIVERSITY'S GRADUATE PROGRAMS EXPANDED TO SEVEN NEW JERSEY COUNTIES AS MASTERS LEVEL STUDENTS ENROLLED IN EDUCATIONAL LEADERSHIP AND ADMINISTRATION CLASSES TAUGHT OFFSITE FOR TRADITIONAL UNDERGRADUATES, FEDERAL PROGRAMS LIKE GCUS \$1.4 MILLION TRIO-SSS GRANT FROM THE U.S. DEPARTMENT OF EDUCATION ARE AMONG THE MANY EXAMPLES OF WAYS GCU SUPPORTS ITS STUDENTS. TRIO-SSS, WHICH HAS BEEN ON GCUS CAMPUS FOR THREE DECADES, OFFERS ACADEMIC TUTORING, PERSONAL COUNSELING, MENTORING, FINANCIAL GUIDANCE, AND OTHER SERVICES, TO HELP UPWARD OF 160 STUDENTS EACH YEAR. IN LATE 2016, THE UNIVERSITY WAS ALSO AWARDED A \$1.9 MILLION GRANT TO SUPPORT CHART THE COURSE, GCUS INTENSIVE RETENTION EFFORT FOR ALL FIRST-YEAR STUDENTS WHO RISK NOT COMPLETING 30 CREDITS BY THE END OF THEIR FRESHMAN YEAR. LAST YEAR, CHART THE COURSE INCREASED FIRST-TO-SECOND YEAR RETENTION FROM 70% TO 85%. THE U.S. DEPARTMENT OF EDUCATION HAS FUNDED THE RETENTION PROGRAM FOR A FIVE-YEAR PERIOD, AND AS A CONTINUATION OF THE ITS SUCCESS, GCU EXPANDED THE INITIATIVE WITH "PATHWAY
