GIFT OF WARMTH: THE UNITED WAY OF MONMOUTH AND OCEAN COUNTIES IS THE TRUSTEE FOR THE NEW JERSEY NATURAL GAS GIFT OF WARMTH PROGRAM. THE PROGRAM ASSISTS FAMILIES IN PAYING THEIR HEATING BILLS DURING TIMES OF FINANCIAL HARDSHIP. NEW JERSEY NATURAL GAS COMPANY MATCHES 100% OF THE DONATIONS MADE UP TO \$80,000. UNITED WAY RECEIVES FUNDS ON BEHALF OF THE MCLTRG AND DISBURSES FUNDS TO ASSIST HOMEOWNERS REBUILD THEIR HOMES AND FOR RELATED ADMINISTRATION COSTS. UWMOC GRANTED OUT ALL REMAINING FUNDS AS OF 6/30/17. DONATIONS IN KIND: IN FISCAL YEAR 2017, UNITED WAY OF MONMOUTH AND OCEAN COUNTIES COLLECTED IN KIND DONATIONS IN TWO MAJOR DRIVES, WARMEST WISHES GIFT DRIVE DURING THE HOLIDAY SEASON AND STUFF THE BUS, SCHOOL SUPPLY DRIVE IN AUGUST.
