COLUMBUS HOUSE STAFF PROVIDE STREET OUTREACH IN NEW HAVEN AND MIDDLETOWN TO WORK WITH PEOPLE WHO DO NOT OR CANNOT COME INTO THE SHELTERS IN THOSE COMMUNITIES. THE GOAL IS TO HELP MOVE PEOPLE INTO HOUSING BY PROVIDING REGULAR ENGAGEMENT AND, ULTIMATELY, CASE MANAGEMENT SERVICES. THE ORGANIZATION ALSO PROVIDES A TRANSPORTATION PROGRAM THAT OFFERS FREE RIDES FOR PEOPLE WHO ARE HOMELESS AND IN NEED OF GETTING TO AND FROM MEDICAL OR TREATMENT RELATED APPOINTMENTS, ANYWHERE IN THE STATE.
