This process, refined after being conducted in York and Adams counties for 20 years, enabled WGSB to collect primary data from Lebanon County residents, share it with key community, hospital and system leaders, and integrate it into the system-wide and entity-level planning processes. Through the consulting support of the Floyd Institute for Public Policy at Franklin and Marshall College, a representative sample of 896 Lebanon County adults were interviewed between February 23 and May 5, 2015 using survey questions derived from the Behavioral Risk Factor Surveillance System (BRFSS), a validated survey tool utilized by the Centers for Disease Control and Prevention (CDC), and organized into four categories: healthcare access, behavioral risk, health conditions, and prevention behaviors and context. Supplemental secondary data from the Robert Wood Johnson Foundation (RWJF) annual County Health Rankings and from the Pennsylvania Department of Health was compiled and integrated into the 2015 CHNA. Data collected and analyzed by the Floyd Institute for Public Policy included breakdowns by age, gender, geographic area, race/ethnicity, and income level, and enabled the development of charts/graphs focused on quantity of residents affected, health risks and disability-adjusted life years, correlates of obesity and depression (two significant health priorities), health disparities, and, social determinants of health impact. This information is included in the 2015 Community Health Needs Assessment Summary Report available at www.wellspan.org. In 2015, CHNA results and related priorities identified by WellSpan-Good Samaritan Hospital and its community partners were shared with the system-wide Planning Committee at WellSpan Health. This Committee is comprised of community members and leaders that represent each of WellSpan's primary entities and service areas, in addition to corporate leadership. Planning Committee members reviewed the CHNA data, adopted WGSB's community priorities of adult overweight/obesity, depression/mental health, and oral health/dental care while also identifying two additional priorities: access related to gaps in care caused by high-deductible insurance plans and the emerging opioid misuse and abuse issue facing the community. These priorities and associated data were subsequently presented to the WellSpan-Good Samaritan Hospital Board for their adoption. CHNA results were made available to the public on the WellSpan Health (www.wellspan.org) website, and may also be obtained upon request.
Part VI - Explanation Of How Organization Furthers Its Exempt Purpose	WellSpan-Good Samaritan Hospital continues to develop its suite of wellness and health education programs designed to address key CHNA findings and to promote healthy lifestyles and disease prevention. These programs include community health screenings, healthy eating initiatives in the community (i.e., healthy cooking demonstrations at the Lebanon Farmers Market), weight management classes, and, physical activity promotion initiatives. Many of these programs are offered for free or at a minimal cost to the participant. In 2016, WellSpan-Good Samaritan Hospital partnered with the Lebanon County Library System to offer the Get Outdoors (GO) Lebanon! summer physical activity program for Lebanon County families. Originated in York County, this summer-long initiative encourages children and their families to be physically active by locating posts hidden in parks throughout Lebanon County. Nearly 2000 children participated in the GO Lebanon! program during its inaugural summer, and 284 participants (14.6%) submitted their program rubbing sheets and collectively walked a total of 2,675 miles. WellSpan-Good Samaritan Hospital continues to strengthen its safety net of services that enables access to care among vulnerable populations through supporting transition of the local Federally Qualified Health Center (FQHC) Welsh Mountain to a connected electronic health record (EHR) platform, and, enrolling financially-challenged community members in Healthy Community Network, a partnership between WellSpan Health, physicians and community partners to support prospective enrollment, the management and support of patients, and coordination of care. WellSpan-Good Samaritan Hospital is an integral partner in the Community Health Council of Lebanon County and, as such, supports key Council initiatives such as the Lebanon County Tobacco Coalition, Lebanon County Teen Pregnancy and Support Network, and Lebanon County Suicide Task Force. Additional community and regional task force leadership and participation includes Better Together, a county-wide collaborative to promote healthy eating and physical activity behaviors, the Lebanon County Heroin Task Force, and, the Opioid Aware coalition, a regional multi-sector collaborative seeking to create coordinated messaging, outreach and management of opioid users in southcentral Pennsylvania. WellSpan-Good Samaritan Hospital participated in system-wide initiatives to address the shared community health priorities of depression (mental health) and adult overweight/obesity. The Feeling Blue depression awareness campaign (www.feeling-blue.com) originated as a resource for York and Adams County adults suffering from mild depression. In 2016, Feeling Blue expanded to Lebanon County and continues to be a valuable resource for its community members. In addition, WellSpan Health celebrated the 5th anniversary of its regional 10Lb Throwdown initiative, a 10-week community challenge that encourages participants to lose or maintain a healthy weight through healthier eating and increased physical activity. The initiative was created to address the growing issue of adult overweight/obesity, and utilizes a core website (www.10poundthrowdown.com) to encourage team participation and to offer an online weight tracker, badges to encourage healthier choices, and diverse health education resources. More than 6200 community members across four southcentral Pennsylvania counties Adams, Lancaster, Lebanon, and York participated in the 2017 iteration of the 10Lb Throwdown program, this represents a 66.5% increase over the prior years program enrollment. Although not a community health priority identified through the recent Community Health Needs Assessment (CHNA), food insecurity in Lebanon County has risen as a potential concern. WellSpan-Good Samaritan Hospital has engaged in two community partnerships to address this issue. First, by providing funding support to Power Packs, nutritious ingredients are distributed to low-income families who can prepare healthy meals for their children on weekends when they are not in school. Additionally, a collaborative relationship with the Lebanon Valley Family YMCA has resulted in a community garden on the Lebanon City YMCA campus farmed by residents and YMCA members, thus promoting healthy eating and physical activity. As of 6/30/17, the allocation of the Debt Capital program was as follows: York Hospital \$159,515,555 (58.09%), WellSpan Properties \$ 29,095,407 (10.60%), WellSpan Health \$12,753,561 (4.64%), WellSpan Specialty Services \$46,131,343 (16.80%), Gettysburg Hospital \$24,900,141 (9.07%), and Good Samaritan Hospital \$2,213,994 (8.1%). These amounts are reported on the respective balance sheets (Part X Line 20) for each of these entities. The 11/12/2008 issue included reissuance of all unspent proceeds from the refunded 2007 bond issue.
