Additional consulting support was provided through a contract with the Floyd Institute for Public Policy at Franklin and Marshall College. Dr. Berwood Yost, Institute Director and Project has an extensive background conducting and analyzing community and corporate surveys, and has been integral to the prior two CHNAs (2008 and 2012). This collaboration of community stakeholders determined the survey questions to be asked of the community, discussed data collection methodology, including sample size and method of obtaining data, reviewed the raw data and supporting charts/graphs, identified potential community health priorities, and, developed the process by which results and priorities were to be shared with the community. The 2015 CHNA planning process engaged a wide range of community organizations serving the diverse interests of all partners without burdening CHNA respondents with too many questions. Committee members reviewed questions asked in the 2012 CHNA and edited accordingly based on the current health care environment and areas of interest. Survey questions were derived from the Behavioral Risk Factor Surveillance System (BRFSS), a validated survey tool utilized by the Centers for Disease Control and Prevention (CDC), and organized into four categories: healthcare access, behavioral risk, health conditions, and prevention behaviors and context. A representative sample of 769 adult residents in Adams County were interviewed between October 27 and December 12, 2014. Supplemental secondary data from the Robert Wood Johnson Foundation (RWJF) annual County Health Rankings and from the Pennsylvania Department of Health was compiled and integrated into the 2015 CHNA. Data collected and analyzed by the Floyd Institute for Public Policy included breakdowns by age, gender, geographic area, race/ethnicity, and income level, and enabled the development of charts/graphs focused on: quantity of residents affected, health risks and disability-adjusted life years, correlates of obesity and depression (two significant health priorities), health disparities, and, social determinants of health impact. This information is included in the 2015 Community Health Needs Assessment Summary Report available at <a href="http://www.wellspan.org">www.wellspan.org</a>. In 2015, CHNA results and related priorities identified by Healthy Adams County were shared with the system-wide Planning Committee at WellSpan Health. This Committee is comprised of community members and leaders that represent each of WellSpan's primary entities and service areas, in addition to corporate leadership. Planning Committee members reviewed the CHNA data, adopted HACs priorities of adult overweight/obesity and depression/mental health while also identifying two additional priorities pertinent to WellSpan Health: access related to gaps in care caused by high-deductible insurance plans and the emerging opioid misuse and abuse issue facing the community. These four priorities and associated data were subsequently presented to the WellSpan-Gettysburg Hospital Board for their adoption. Board members discussed the data and identified priorities within the context of existing staffing and financial resources, current and future entity initiatives, and community partnership opportunities to address systemic community change.</p>

Through financial and management support of a county health coalition, Healthy Adams County (HAC), more than 100 Adams County community members have been engaged in community health improvement initiatives. Some examples of past collaborative efforts include supporting the establishment of a Federally Qualified Health Center (FQHC) to increase primary and dental care capacity for underserved individuals, improving adolescent health and decreasing teenage pregnancy rates through targeted task force initiatives, increasing awareness of domestic violence through community awareness and education, and, addressing unhealthy eating behaviors by establishing the Adams County Food Policy Council. This Healthy Adams County-affiliated task force has demonstrated continued success in improving the availability of fresh, healthy and affordable produce to a growing number of underserved community members through its Healthy Options program. In fiscal year 2017, more than 100 low-income households were provided with vouchers for fresh fruits, vegetables, breads and meats at participating Adams County farmers markets. As a charitable, community-based healthcare organization, our commitment to improving the lives and well-being of the people and communities we serve is evident in our mission statement: Working as one to improve health through exceptional care for all, lifelong wellness, and healthier communities. Employees live out this mission statement every day by engaging in community benefit activities that address community needs, especially the four health priorities identified in the 2015 CHNA: adult overweight/obesity, access related to gaps in care caused by high-deductible insurance plans, depression/mental health, and, opioid misuse and abuse. Access to healthcare and medications for uninsured community members or those with high out-of-pocket costs is often financially challenging. Healthy Community Network, a collaborative between WellSpan Health, physicians and community partners to support prospective enrollment, the management and support of patients, and coordination of care, serves as a support for those individuals, offering free or discounted resources based on need. In addition, through support of the Family First Health Gettysburg Center, medical and dental services were provided to 7,087 and 4,254 patients, respectively. Feeling Blue, an online depression awareness campaign (<a href="http://www.feeling-blue.com">www.feeling-blue.com</a>) launched in November 2014, continues to demonstrate increased online traffic (viewer hits). The campaign is designed to encourage individuals who are feeling blue or suffering from mild depression to engage in non-medical means of managing their symptoms (i.e., healthy eating, increased physical activity, social support). Since its launch, the Feeling Blue campaign committee with representation by behavioral health providers across the community - annually updates the website with new information to support community members suffering from mild depression as well as working to reduce the social stigma associated with this prevalent mental health condition. In 2017, WellSpan Health celebrated the 5th anniversary of its regional 10Lb Throwdown initiative, a 10-week community challenge that encourages participants to lose or maintain a healthy weight through healthier eating and increased physical activity. The initiative was created to address the growing issue of adult overweight/obesity, and utilizes a core website (<a href="http://www.10poundthrowdown.com">www.10poundthrowdown.com</a>) to encourage team participation and to offer an online weight tracker, badges to encourage healthier choices, and diverse health education resources. More than 6200 community members across four southcentral Pennsylvania counties Adams, Lancaster, Lebanon, and York participated in the 2017 iteration of the 10Lb Throwdown program, this represents a 66.5% increase over the prior years program enrollment. Healthy Adams County, in partnership with WellSpan-Gettysburg Hospital and other community organizations, also launched the Community Wellness Connections initiative. Designed around the eight dimensions of wellness, participants engage in monthly educational sessions and interactive experiences that encourage personal growth. Opioid use, as in other communities across the United States, has become a crisis in Adams County. WellSpan Health staff regularly participate in community level opioid dialogues, and on the Opioid Aware coalition, a regional multi-sector collaborative seeking to create coordinated messaging, outreach and management of opioid users in southcentral Pennsylvania.
