Fall 2016: Colour Brillante - a mixed repertoire, semi-professional ballet program featuring four choreographic works - 3 performances
This production featured the work of three local choreographers. Brandywine Contemporary Resident Choreographer, Tim Early's, Metamorphosis opened the show, and featured eight dancers. Next on the program was Kores Dance Company Member, Joe Cotler's, The Departure, featuring twelve of our younger student dancers. Followed by Brandywine Ballet Resident Choreographer, Nancy Page's, Never Ending Road, set to the hauntingly beautiful music of Loreena McKennitt and featuring both student and professional dancers. The main work headlining the show was Nancy Page's Colour Brillante, set to a beautiful classical score by Antonin Dvorak. This work highlights gorgeous pas de deus, tight small-group work, and striking ensemble sections.

Winter 2016: The Nutcracker - a full length, semi-professional ballet - 8 performances
The Nutcracker is a beloved holiday traditon in communities around the world. Brandywine Ballet proudly presents this full-length classic ballet every December. The quality of this ballet and its sets and costumes, are formidable components of our annual production, where we bring the best possible production of our audiences. The Nutcracker features over 135 dancers in 40 roles, with dancers ages ranging from seven through adult professionals. Tchaikovsky's timeless score and the captivating choreography transport viewers alongside Clara on the magical journey of a dream, bringing enchantment to all who encounter it.

Spring 2017: Beauty & The Beast - a full length, semi-professional ballet - 4 performances
This production was our premiere of Nancy Page's Beauty & The Beast. Based on the classic French tale by Gabrielle-Suzanne Barbot de Villeneuve, a spell is cast, transforming the fate of a Prince and his entire castle, holding them in restraint, until the day that the Prince learns to love and is loved in return. It is a tale of overcoming one's fears, vulnerability, love, and the lesson that beauty is much more than skin deep. Ms. Page's imaginative cast of characters, innovative choreography, and carefully selected musical score took the audience on quite an adventure.

We provide three fully staged, professional productions each season at our home theatre, Emilie K. Asplundh Concert Hall, on the campus of West Chester University. Our organization strives to enrich the lives and capabilities of our student dancers by offering special classes where they train at high levels with their peers, and by providing challenging performance opportunities throughout the year where they will rehearse and perform alongside professional and pre-professional dancers in our Company. Two additional training regimens we offer our Master Class sessions and our Summer Intensive sessions. Both feature talented teachers from the dance world, resulting in an exposure to different teaching styles and approaches to technique and artistry that nicely supplements the dancers ongoing training.

Reaching those in our community who would not otherwise have the opportunity to experience the ballet is also important to Brandywine Ballet. In that light, we provide discounted tickets to student and senior groups, complimentary tickets through Art-Reach and VetTix services, and we provide lecture demonstrations on what Ballet is all about.

PART III #4d - In addition to Brandywine Ballet's Fall, Winter, and Spring performance series, we also appeared in various dance festival engagements: the West Chester University Alumni Dance Festival, the Chester County Dance Festival, and the Philadelphia Youth Dance Festival.
