The Committee memorializes all of its deliberations in detailed Committee Minutes that are reviewed and corrected, if necessary and approved at its following meeting. 7. The Committee acquires an opinion of counsel concluding that the process followed by the Committee meets the requirements of the IRS regulations. 8.
