The Museum of Art is partially supported by state appropriations that largely fund state staff positions and their related benefits, and a small portion of the operating costs of running the Museum. The North Carolina Museum of Art Foundation, Inc. provides the majority of financial support needed for education and curatorial programming of the Museum of Art including support for statewide and museum-based education programming, special traveling art exhibitions, supplemental art conservation funds, and public programming.

Form 990, Part III, Line 4b:

The North Carolina Museum of Art Foundation, Inc provides additional support to the Museum of Art by cultivating donors for commissioned works of art and contributions for art acquisitions. All art purchased or commissioned is gifted by the Foundation to the North Carolina Museum of Art. A large majority of the artwork added to the State's art collection is gifted by the Foundation.

Form 990, Part III, Line 4c:

The North Carolina Museum of Art Foundation Inc owns 34 acres of the street frontage of the museum and has made significant investments in developing this property as the garden gateway to the Museum and Museum Park which sits on 130 acres of state property. The Foundation completed a \$13M park expansion project during the 2016/17 fiscal year, with a formal park opening in November of 2016. This investment was capitalized as land improvements. Continued investment in park trails, structures, art and ongoing maintenance can be expected for years to come.

The investment policy was developed with the long-term interests of the endowment in mind and adheres to accepted investment and financial management principles. The investment policy is designed to ensure prudent management of the assets in order to serve the best long-term interests of the Foundation. The Foundation expects its endowment funds, over time, to provide a total real rate of return of 5%, net of fees, over a three-year rolling average. Actual returns in any given year may vary from this amount. While the Foundations historical spending policy reflects an intended appropriation of 5% of the endowment funds for distribution each year in keeping with the anticipated investment return, the board closely monitors anticipated investment returns relative to current market conditions each year. Effective July 1, 2016, the board amended its spending policy to reflect a 4% distribution of assets annually. While the stated goal of earning at least 5% annually has not been revised, any investment returns in excess of the revised annual distribution of 4% will remain invested in the endowment and will earn additional returns until appropriated in future years.

The North Carolina Museum of Art Foundation, Inc. is a non-profit organization in support of the state museum. Given the common goals of these two organizations, Dr. Wheeler exercises significant influence relative to both entities and his primary compensation through the State of North Carolina is supplemented significantly by the North Carolina Museum of Art Foundation, Inc. (67%). In addition to salary supplements, the Foundation maintains a consulting agreement with Dr. Wheeler which provides additional compensation in exchange for his expertise and involvement in various fundraising activities, particularly as they relate to the cultivation and solicitation of collectors and donors. The most recent consulting agreement commenced on July 1, 2015 and is for a two year period ending June 30, 2017. Under this agreement, Dr. Wheeler receives quarterly consulting fees, semi-annual retention fees, and the services of a third party financial planning consultant paid by the Foundation.
