THE WORK2GETHER GRANT FUNDS SUPPORT COMMUNITY ENGAGEMENT ON EDUCATION ISSUES. PILOT PROGRAMS FOR KINDERGARTEN COUNTDOWN WERE LAUNCHED IN 2015 AT FOUR ELEMENTARY SCHOOLS IN MARSHALL COUNTY. THESE PROGRAMS REACHED NEARLY 80 CHILDREN WHO HAD NOT HAD PREVIOUS EXPOSURE TO PRESCHOOL OR DAYCARE IN EFFORTS TO INCREASE THE NUMBER OF CHILDREN WHO ARE KINDERGARTEN-READY AND ON TRACK WITH THE PEERS ENTERING SCHOOL.
