UFM Community Learning Center is a creative educational program serving Kansas State University, the Manhattan, KS, area and the state of Kansas. UFM provides opportunities for lifelong learning and idea exchange. UFM also serves as a catalyst and host for new programs and services that enhance the quality of life for all.

UFM Educational Program: This is UFM's largest program and primary mission activity. The educational program offers a wide variety of noncredit and credit courses and workshops. In FY17, UFM offered 824 noncredit classes and 228 courses offered for credit through Kansas State University. 3,606 (unduplicated) persons took noncredit classes and another 1,909 received K-State credit. Class topics included aquatics, creative free time, foods and nutrition, earth and nature, health and wellness, recreation, languages and martial arts. Total participation in all UFM activities was 15,301. UFM is the sole Licensed Training Provider for the American Red Cross in the Manhattan area and is the largest provider in Kansas. UFM collaborates with many other organizations to serve the community and participates in community awareness activities. UFM continued to host Osher Lifelong Learning Institute classes in collaboration with the University of Kansas and K-State Global Campus. This year we had 660 enrollments in classes offered during the year. UFM added oversight of the Manhattan Nonviolence Initiative as a new program area. UFM continued to host the office for the Flint Hills Renewable Energy and Efficiency Cooperative. UFM serves as the host for noncampus groups using the KSU Ahearn Complex. 4,073 attended events in FY17.

Manhattan Area Risk Prevention Coalition (MARPC): UFM receives and administers funds on behalf of MARPC, a coalition of 12 community sector representatives. The focus of the coalition is risk reduction and prevention among youth, especially in the area of drug/alcohol use issues and prevention activities. In FY17, MARPC received a planning grant from the Kansas Department of Aging and Disability Services as well as the first year of a federal Drug Free Communities grant. The focus of the grants was capacity building, improving the organization and function of the coalition. Funding was also used for community education through a media campaign on social hosting and messages on ways parents can talk to their children about alcohol use. MARPC coordinated Sticker Shock events in Manhattan and at Fort Riley. About 60 volunteers put stickers focused on not providing alcohol to minors on 10,000 packaged goods in liquor stores.

UFM Teen Mentoring Program: The Teen Mentoring Program offers a structured program of support and life skills to youth in grades 7-12. Project goals for the teens include learning positive life skills and focusing on primary prevention and intervention activities. Students from Kansas State University serve as mentors. Participant referrals come from the schools, community corrections, parents and teen participants who bring their friends. In FY17, the program offered groups three afternoons a week. 81 youth were served and 38 K-State students served as mentors.

Part III. 4d 1. Manhattan Community Garden Expenses: \$9,879 Grants: \$0 Revenue: \$21,533

Low cost gardening plots are available to Manhattan and Riley County residents. Print newsletters are produced twice during the gardening season. An electronic newsletter is sent weekly. Power tools, hand tools, hoses and some seeds are provided. Land is leased from the City of Manhattan, KS and Riley County, KS. In FY17, 168 families gardened 280 plots. Revenue appears to be high because plot signups overlap two fiscal years with much of the revenue for the following year being collected in the current year. Excess funds are routinely set aside for future garden development and equipment replacement purchases.

Part III. 4d 2 Project EXCELL (Extending College Education for Lifelong Learning) Expenses: \$13,017 Grants: \$0 Revenue: \$18,817

Project EXCELL provides area adults with mild developmental/intellectual disabilities enrichment classes in a college-like environment. Traditional college students serve as mentors and classroom aids. Classes are held on Saturday mornings during the fall and spring semesters. In FY17, 74 students were enrolled and 142 KSU students assisted. Excess funds reflect donations for the next school year being captured in the current year. These funds are carried over to insure that the program has adequate funding for the coming year.

Part III. 4d 3. Lou Douglas Lecture Series Expenses: \$11,582 Grants: \$0 Revenue: \$24,100 (includes carryover from previous year)

This lecture series brings speakers to the K-State campus. The theme of the series is social justice, human rights and world peace. In addition to lectures, speakers often visit K-State classes, meet with students and when appropriate, participate in campus and community events. In FY17, speakers included Lecia Brooks from the Southern Poverty Law Center speaking on teaching tolerance, and Tim Wise, talking about racism in America. Over 2,000 attended these lectures.

Part III. 4d 4. Manhattan Nonviolence Initiative Expenses: \$6,661 Grants: \$0 Revenue: \$28,334

This new project began in February, 2017, so had been functioning only 4 months at the end of the fiscal reporting year. The focus of this project is to make and maintain a safe and equitable campus and community through the practice of everyday nonviolence. Activities include creating community conversations, gatherings such as the fall music festival and participating in collaborative meetings with others interested in civil discourse on community issues. From February - June, 2017, 359 individuals participated in MNVI activities. The funding shown is for a two-year period.

Carry over funds are used to purchase equipment and supplies, add additional services and in some cases replace funds that are lost due to changes in program funding.
