Feeding the hungry has always been an integral component of Christian Community Action's mission to provide help to those in need. In 1989, CCA staff began regularly stocking a small office closet with donated food for clients. Today, CCA operates the largest client-choice food pantry in North Texas, providing food, personal hygiene and household products to more than 500 families every week. CCA's client-choice distribution model empowers clients to choose which foods they will take home, providing flexibility and preserving the dignity of the client receiving assistance. With almost 40% of their food provided by CCA's food Pantry, families are able to reserve their limited household income for other essentials such as rent, utilities, childcare and healthcare. Last year CCA's food pantry distributed more than 1,800,000 pounds of food, including 700,000 pounds of fresh fruits and vegetable to 1,489 families.

Form 990, Part III, Line 4b:

Christian Community Action's Family Assistance program provides financial support and counseling to families who are at imminent risk of eviction or foreclosure. Assistance generally consists of short-term (3 months) or medium-term (6 months) rental assistance, rental arrears, rental application fees, security deposits, advance payment of last month's rent, utility deposits and payments, utility arrears and housing stability counseling and case management. With only one limited-capacity homeless shelter in Denton County and little-to-no affordable housing in the area, CCA is a vital resource for families at risk of homelessness due to eviction or foreclosure assisting 851 individuals last year. As a result of CCA's homeless prevention program and case management, CCA was able to save North Texas tax payers potentially \$30,000 - \$50,000 annually.
